#### **CALL TO ORDER:**

Meeting called to order by Chair at 7:05 PM.

The Chair explained the purpose of this meeting is to give residents and any interested parties an opportunity to review and comment on the proposed amendments copies of the draft proposal circulated. The chair noted that whereas Council has identified minor issues with the existing wording of Section 3 and Section 3.24 of the Community of Kingston Zoning and Subdivision Control bylaws Council is proposing amendment 2017-01. He noted a document is available at the back showing both the existing wording and the proposed amendments required to update the bylaws.

He further stated that Council has not been satisfied with the existing regulations pertaining to accessary buildings for some time, adding they have been cumbersome to work with and in some instances did not seem reasonable. He then passed the floor over to Keith Boire who drafted the proposed Amendment 2017-01 to this section of the Community of Kingston Zoning and Subdivision Control Bylaws.

At this point Councilor Boire took the floor and explained the principle behind amending the existing regulations and went through the modifications line by line.

It was noted by one resident that the link on the website would not work, and that individual contacted the Administrator and was emailed a copy of the proposed amendment. The resident also questioned if the Community could devise more ways of engaging the residents in Community activities.

The Chair also took this opportunity to advise those present of the recent discussions that have taken place around the new *Municipal Act* and a suggestion was made from a resident concerning naming the new Municipality.

It was decided to change the donation line item to \$6,000.00 and change the revenue for permit fees to \$2,000.00. Councilor Ireson will make the modifications and circulate the revised budget for 2017.
