## **CALL TO ORDER:**

Meeting called to order at 7 PM by Chair.

### **CHAIRS REPORT:**

### FINANCE REPORT:

Councilor Julie Ireson presented the audited financial report and balance sheet line by line to those present. She explained the breakdown of the professional fees allocation.

Councilor Ireson then presented the 2017 Community Budget line by line.

#### MOTION:

"To appoint Councilor Ireson to take the task of leading the 2018 budget process on behalf of Council." (M) Dwight Thompson (S) Keith Boire, Motion Carried.

### **BUILDING PERMIT REPORT:**

Councilor Thompson Presented the 2016 Building report for those present. A Question was asked on the Westwood Phase 2 expansion and it was noted that this was approved retroactively by the Province. The Chair thanked Councilor Thomson for the great job he has done in 2016.

## MOTION:

"To appoint Councilor Thompson the lead on the task of reporting the 2017 Building Report." (M) Julir Ireson (S) Tom Coady, Motion carried.

**OFFICIAL PLAN:** Noted the Bylaws concerning accessary buildings are being amended to correct the wording of the regulations.

#### **BLACK FLY PROGRAM:**

Noted the Community will be engaging Atlantic Bugbusters again in 2017. Noted that item no longer need be included in the Annual reports.

- 1. Discussed the Amalgamation process.
- 2. Discussed the implications of the new Municipal Act noting the regulations have not yet been completed. It was decided to invite a representative from the Province to the May meeting to discuss the impact of the regulations to our Community.
